CONVERSION OF PERFORMANCE RIGHTS

GALENA MINING LTD ("**Galena**" or the "**Company**") **(ASX: G1A)** advises that it has converted 2,500,000 Class 3 Performance Rights ("**Perfromance Rights**") to fully paid ordinary shares ("**Ordinary Shares**").

The relevant tranche of Performance Rights is part of the package of Performance Rights issued to Galena's CEO, Alex Molyneux and as approved by shareholders at a General Meeting held 19 October 2018.

The trigger for the conversion of the relevant tranche of Perfromance Rights is the vesting date, being 1 September 2020 and on completion of project development funding for the Abra Base Metal Project (ie, for the Company to have cash available plus committed facilities, joing-venture arrangements, product pre-payment arrangements or royalty facilities equivalent to cover its share of the estimated remaining project development capital expenditure for the Abra Base Metal Project at any give time) (Milestone 1).

The Appendix 2A and Notice Under Section 708A in respect of the Ordinary Shares issued are appended to this announcement.

The Board of Directors of Galena authorised this announcement for release to the market.

About Abra Base Metals Project

77.28% owned by Galena, the Abra Base Metals Project ("**Abra**" or the "**Project**") is a globally significant lead-silver project located in the Gascoyne region of Western Australia (between the towns of Newman and Meekatharra, approximately 110 kilometres from Sandfire's DeGrussa Project).

Galena completed an outstanding definitive / bankable feasibility study ("**FS**") (see Galena ASX announcement of 22 July 2019) for development of a mine and processing facility with a 16-year life producing a high-value, high-grade lead-silver concentrate containing approximately 95kt of lead and 805koz of silver per year after ramp-up. Based on a pre-development capital expenditure estimate of A\$170 million, the FS modelled a pre-tax net present value for Abra (at an 8% discount rate) of A\$553 million and an internal rate of return of 39%.¹


