CONVERSION OF PERFORMANCE RIGHTS

GALENA MINING LTD. ("Galena" or the "Company") (ASX: G1A) advises that it has converted 2,500,000 Class 6 Performance Rights ("Perfromance Rights") to fully paid ordinary shares ("Ordinary Shares").

The relevant tranche of Performance Rights is part of the package of Performance Rights issued to Galena's CEO, Alex Molyneux and approved at a General Meeting held 19 October 2018. The trigger for the conversion of the relevant tranche of Performance Rights is when the volume-weighted average share price ("VWAP") for the last 20 business days of the Company's share trading on the ASX equals or exceeds A\$0.40/share ("Share Performance Milestone"). During the period from 29 March 2019 to 30 April 2019, Company's VWAP for 20 business days was \$0.401. Consequently the Share Performance Milestone for Class 6 Performance Rights has now been met.

At the time of issuance of the Performance Rights, the Share Performance Milestone that has been triggered for the relevant tranche being converted today represented a 135% premium to the Company's share price. The Board is pleased the milestone has been achieved and with the great progress that has been made on advancing the Company's Abra Base Metals Project.

About Abra Base Metals Project

91.11% owned by Galena, the Abra Base Metals Project ("**Abra**" or the "**Project**") is a globally significant lead-silver project located in the Gascoyne region of Western Australia (between the towns of Newman and Meekatharra, approximately 110 kilometres from Sandfire's DeGrussa Project).

Galena recently completed an outstanding pre-feasibility study ("**PFS**") (see Galena ASX announcement of 25 September 2018) for development of a mine and processing facility with a 14-year life producing a high-value, high-grade lead-silver concentrate containing approximately 91kt of lead and 760koz of silver per year after ramp-up. Based on a pre-development capital expenditure estimate of A\$154 million, the PFS modelled a pre-tax net present value for Abra (at an 8% discount rate) of A\$528 million and an internal rate of return of 50%.¹


